SUMMARY ANNUAL REPORT FOR PLUMBERS' RETIREMENT SAVINGS FUND, LOCAL 130, U.A.

This is a summary of the annual report for Plumbers' Retirement Savings Fund, Local 130, U.A. Plan, EIN 86-0928669, for the year ended December 31, 2024. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by Trust.

Plan expenses were \$27,830,829 consisting of \$27,187,453 of benefits paid to participants and beneficiaries, and \$643,376 of other administrative fees. A total of 6,158 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan was \$448,336,587 as of December 31, 2024, compared to \$398,393,172 as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$49,943,415. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$77,774,244 including (but not limited to) employer contributions of \$23,725,751, participant contributions of \$3,118,886, participant rollovers of \$218,339 and earnings from investments of \$50,248,880.
